NEW BUSINESS

Concept Plan - 469 Limestone Road, Oxford, PA 19363 - 2-Lot Subdivision and Land Development

Mr. Swiernik, David Miller Associates, presented a two-lot subdivision and Land Development Concept Plan to the Planning Commission for a geoprobe business located at 469 Limestone Road, Oxford, PA. The following comments were discussed regarding the project:

- The proposed land development plan meets the area and bulk requirements.
- The first proposed building on the lot where the cell tower is located will be for future commercial use that will require a conditional use hearing due to a second use proposed on the property.
- There is a possibility of moving the building on the first lot forward to have additional parking space in the back which will also allow for more space from the existing cell tower.
- The buildings proposed on each lot will not exceed the 35' maximum height requirement.
- Tractor trailer traffic will be a one-way in and a one-way out.
- The developer will touch base with the cell tower owner as to what to expect in case of a cell tower collapse.
- Will verify with Township Engineer if screening will be required because it abuts the commercial golf course.
