## § 27-1411 Applications for Conditional Uses.

[Ord. 1-71, 3/2/1971, § 1412]

Application for a conditional use shall be made to the Board of Supervisors and shall be accompanied by a plan of the property showing the details of the use proposed, along with other written and graphic material required by this Chapter 27. The applicant shall notify all adjacent lot owners of said application for a conditional use and advise them of the date, time and place of the conditional use and advise them of the date, time and place of the conditional use hearing. The application shall be accompanied by such fees as shall be set forth in a resolution of the Board of Supervisors, in an amount sufficient to cover all Township costs. Five copies of the application with all supporting documents shall be submitted.

## § 27-1412 Procedure.

[Ord. 1-71, 3/2/1971, § 1413; as amended by Ord. 1-93, 1/6/1993]

- 1. Upon receipt of an application for conditional use, the Board of Supervisors shall promptly send copies of the application and all supporting materials to the Lower Oxford Township Planning Commission, the Chester County Planning Commission, and the Chester County Health Department.
- 2. The Planning Commission shall be promptly review and consider the application and all supporting materials including any Neighborhood Impact Analysis as required by either the Board of Supervisors or the Planning Commission and shall return the application and all supporting materials to the Board of Supervisors, along with its recommendations thereon.
- 3. The Board shall schedule a hearing and render a final decision thereon in accordance with § 27-1501.
